

# 1. NOTICE OF FIRST STAGE OF CONSULTATION

National Electricity Rules – Rule 8.9

# 1.1. Five Minute Settlement – NEM Settlement Estimates Policy Date of Notice: 26 November 2018

This notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on the NEM Settlement Estimates Policy as a result of the Five-Minute Settlement rule change.

This consultation is being conducted in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

### **Matter under Consultation**

The matter for consultation involves changes to the NEM Settlement Estimates Policy to implement the Five-Minute Settlement rule and accommodate any future Global Settlement rule, as well as general updates and improvements. Further details are provided in the Issues Paper published with this notice. A consultation draft of the policy is also published with the Issues Paper.

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.



Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

## Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
