# Victorian Jurisdictional Derogation – RERT Contracting

Date of Notice: 13 March 2020

This notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is commencing its consultation on changes to the Procedure for the Exercise of the Reliability and Emergency Reserve Trader (Procedure) related to the Victorian Jurisdictional Derogation – RERT Contracting rule change.

This expedited consultation is being conducted under clause 11.121.2 of the National Electricity Rules (NER).

## Matter under Consultation

The matter for consultation is a minor update to the Procedure to implement the 'Victorian Jurisdictional Derogation – RERT Contracting' rule determination dated 12 March 2020 (<u>linked here</u>). This update reflects that clause 3.20.3(m) of the NER does not apply to AEMO in respect of multi-year Victorian contracts.

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.



# Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
