# **Baselines Eligibility Compliance and Metrics Policy**

Date of Notice: 18 December 2020

This Notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on the draft Baseline Eligibility Compliance and Metrics Policy (Policy).

This consultation is being conducted under clause 3.10.2 of the National Electricity Rules (NER), in accordance with the Rules consultation procedures set out in NER rule 8.9.

### Matter under Consultation

The matter for consultation is the draft Policy, which establishes the methodology by which the AEMO will determine baseline eligibility and compliance under the wholesale demand response mechanism and sets out the thresholds for baseline compliance metrics.

Further details are provided in the Issues Paper published with this Notice, together with the draft Policy.

#### **Invitation to Make Submissions**

AEMO invites written submissions on the matter under consultation, including any alternative or additional proposals you consider may better meet the objectives of this consultation and the national electricity objective in section 7 of the National Electricity Law.

Please identify any parts of your submission that you wish to remain confidential and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.



# **Meetings**

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons and may publish them.
